- Atty. Arcangeles verified if the bidding at hand is within the approved Annual Procurement Plan (APP) for the year 2018.
- The Committee together with Miss Vito checked and confirmed that the said procurement is included in the 2018 approved APP.
- Having no other comments on the Invitation To Bid, the Committee proceeded to the Checklist of Requirements for Bidders.
- After the Committee carefully checked the Eligibility/Technical Requirements, they proceeded to the Technical Specifications.
- The Committee reviewed the technical specifications and found everything in order.
- There being no other matters to be discussed regarding the pre-bid conference, the meeting was adjourned at 10:55 A.M.
