NAME OF THE PROJECT: Contract for the Procurement of Janitorial Services

- b.) For Corporation, Cooperative, or Joint Venture-"Secretary's Certificate" issued by the Corporate Secretary indicating the Board Resolution No. granting full power and authority to do, execute and perform any and all acts necessary for the bidding at hand; or
- c.) For Partnership a "Joint Special Power of Attorney (SPA)" issued by concerned Partners granting full power and authority to do, execute and perform any and all acts necessary for the bidding at hand.
- $18.\ \mathsf{Complete}$ list of janitorial employees duly signed by the bidder or its duly authorized representative;
- 19. Social Security System (SSS) Contribution Remittance Certificate of Clearance for the 4th quarter of fiscal year 2021 issued by the SSS (any delinquent remittances shall be valid ground for the disqualification of bids);
- 20. PHILHEALTH Insurance Corporation Contribution Remittance Certificate for the 4th quarter of fiscal year 2021 issued by the Philhealth Office (any delinquent remittances shall be valid ground for the disqualification of bids);
- 21. Pag-Ibig Fund Contribution Remittance Certificate to be issued by its office indicating the payments of their utility workers for the 4^{th} quarter of 2021 (any delinquent remittances shall be valid ground for the disqualification of bids);
